

**ORDINANCE NO. 2998**

**AN ORDINANCE OF THE CITY OF TERRELL, KAUFMAN COUNTY, TEXAS, AMENDING APPENDIX 1 FEE SCHEDULE OF THE TERRELL CITY CODE OF ORDINANCES, SECTION 3. ATHLETIC FIELDS — FEES AND CHARGES; PROVIDING FOR SEVERABILITY, PROVIDING A PENALTY AND PROVIDING AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TERRELL, KAUFMAN COUNTY TEXAS:**

**ARTICLE I.**

**THAT** Appendix 1, Fee Schedule of the Terrell City Code of Ordinances, Section 3, Athletic Fields — Fees and charges, is amended as follows:

**Sec. 3 Athletic Fields — Fees and charges.**

The following schedule of fees for use of athletic Fields at the municipal parks shall be and such is hereby adopted and established as follows:

**(1) Athletic Fields ~ User fees for all City leagues.**

Five Dollars (\$5.00) per participant per season (to include regular season league play, end of season league playoffs, and special league tournaments).

**(2) Athletic Fields - User Fees for non-City Leagues**

**(a) Practice fees for Team Practice or Independent games (per practice and/or game for non-league team{s}):**

- (i) No Field Preparation, No Lighting ----- \$25.00 per hour**
- (ii) With Lighting, Add ----\$25.00 per hour**

**(b) All Tournament Fees**

Per Team per day.....\$150.00 One day Tournament  
Per Team per day.....\$100.00 Two day Tournament

**Penalty**

Any person violating any of the provisions of this section shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in any sum not to exceed Five Hundred Dollars (\$500.00).

**ARTICLE II**

All Ordinances or parts of Ordinances in conflict herewith are to the extent of such conflict hereby repealed.

**ARTICLE III**

It is hereby declared to be the intention of the City Council of the City of Terrell, Texas that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections.

**ARTICLE IV**

All other provisions of Appendix 1 not expressly modified by this Ordinance shall remain in full force and effect.
